WHEREAS, the City of Key West Board of Commissioners (Board) for the City of Key West was organized by referendum on November 3, 2002; and

WHEREAS, the City is authorized by statute by Executive Director to provide the day-to-day business affairs of the City; and

WHEREAS, the City selected Stephen Muller as Executive Director of its member of September 2008 and wishes to renew his term; and

WHEREAS, the Contract Employee has agreed to perform the services required for the City under the terms of this Agreement; and

NOW, THEREFORE, in consideration of the mutual covenants herein contained, the parties agree as follows:

Section 1 - TERM

1.1 The City hereby employs the services of the Contract Employee to perform the positions and duties assigned by the City and carry out its departmental functions.

Section 2 - TERM

2.1 The Agreement & for services to be performed commencing on October 1, 2015, and to continue "at will" until terminated, unless sooner terminated as provided herein.

2.2 The City, acting on behalf of the City, and the Contract Employee shall retain the right to terminate this Agreement immediately or any time, with or without cause.

Section 3 - SALARY AND ALLOWANCE

3.1 The City shall pay the Contract Employee for services rendered pursuant to this Agreement an annual salary of \$12,000.00 (twelve thousand dollars and no cents) plus a 10% cost of living allowance.
